1. Purpose

1. The Welsh Clay Target Shooting Association is the governing body of clay target shooting in Wales. Its primary function is to organise, regulate and promote the development of the sport of clay target shooting within Wales. The Association will provide insurance for members whilst engaged in shooting activities and try to encourage those people engaged in shotgun shooting to be insured by becoming members.
2. These rules have been formulated by the WCTSA board for all disciplines and events controlled by them. Technical rules for all disciplines will be those of the ICTSC and CPSA rulebooks.
3. For any events not covered by this rule book the rules of the ICTSC will apply.
4. Any national ISSF or FITASC events held by the WCTSA will be run under the current rules issued by the governing body of that discipline.

2. Management

1. The management of the Association is undertaken by the Board.
2. The composition and makeup of the Board is described in the WCTSA articles of association.
3. Election of members to the board is also described in the WCTSA articles of association.
4. Contact details of Board Members shall be displayed on the WCTSA website.
5. The current articles of association of the WCTSA can be found on the WCTSA website.
6. Membership categories and subscription fees for joining the Association can be found in Appendix 6 and are also detailed on the WCTSA website.
7. The Board undertakes to ensure there is suitable insurance policies in place to cover its members for shooting sports. The current insurance policy documents are available on the WCTSA website.

3. Affiliated Shooting Grounds / Clubs (Membership, Responsibilities, and Levies)

1. All affiliated grounds / clubs must appoint a qualified Safety Officer.
2. All affiliated grounds / clubs must have an up-to-date Health and Safety policy.
3. Affiliated clay target shooting grounds / clubs wishing to hold Welsh team selection shoots or other sanctioned WCTSA events, shall undergo a ground inspection by a designated member of



- the Board, using the ground / club affiliation & safety declaration criteria. This criterion is available on the WCTSA website.
4. At the beginning of each calendar year, all affiliated grounds / clubs must sign a terms and conditions agreement as a requirement of their membership, and to enable them to host WCTSA sanctioned events.
 5. All grounds / clubs selected to hold WCTSA sanctioned events MUST return a signed affiliation document before the end of January, in the year in which the events are scheduled.
 6. Ground / club affiliation fees are due on the 1st of January each year and grounds / clubs will be invoiced by the Treasurer / Secretary of the WCTSA.
 7. Any ground / club with an outstanding invoice(s) will not be eligible to hold shoots the following year.
 8. Affiliated grounds / clubs must complete and return ALL required documentation in a timely manner. Failure to do so may result in the board not awarding any of the WCTSA sanctioned events which they have applied for.
 9. Levies.
 - a. Affiliated grounds / clubs will be charged the appropriate levy for ALL entrants at a WCTSA sanctioned event (as outlined in Appendix 1 of this rulebook), regardless of which Association they are a member of and whether they are shooting competition or birds only.
 - b. The Board will invoice the affiliated ground / club for the total levies due from any sanctioned WCTSA event such as, but not limited to:-
 - i. County Competitions
 - ii. Welsh Team Selection Events / Qualifiers
 - iii. Welsh Open Competitions
 - iv. Welsh Grand Prix Competitions
 - c. Details of the current levy charges for the different membership categories can be found in Appendix 1 of this rulebook.
 - d. Invoices for levies will be issued by the WCTSA Treasurer and payment is to be returned within 14 days of receipt of the invoice.
 10. Affiliated grounds / clubs can administer and run WCTSA sanctioned events providing they fully comply with all the provisions contained in this rulebook, and in the rulebook for the discipline concerned and / or any additional conditions approved by the WCTSA.



11. Affiliated grounds / clubs must elect a Jury consisting of no less than five persons on the morning of any WCTSA sanctioned event, and a notice displayed at the entry desk giving this information before shooting starts at all registered events. The role of the Jury is that of overseeing the running of the event. They must check at the beginning of a competition and where they feel necessary, reset the targets as per the Technical Rules of the discipline. To carry out the duties and responsibilities allocated to them as per the rulebook of the discipline concerned and to make all decisions directly relating to the fairness of the competition. A Jury levy fee of £25 must be paid for any protest made, if the Jury upholds the protest, then the fee shall be returned. Any shooter bringing an issue to the jury must first pay a Jury levy of £25, which will be returned to the shooter in the event of their complaint or issue being upheld. In instances where the issue or complaint is not upheld the Jury Levy must be passed on by the affiliated ground to the WCTSA.
12. Any membership fees collected by affiliated grounds / clubs must be passed on in full to the WCTSA Treasurer within 1 week, to ensure the shooters membership status is updated as soon as possible.
13. Affiliated grounds / clubs holding sanctioned WCTSA events must register their scores with the CPSA via the Shoot program. Grounds / clubs not registered with the CPSA must send their scores to the WCTSA Secretary for processing. Scores must be sent in a clear & concise format. Photographs of written scoreboards or scoresheets are not acceptable. Failure to do so may result in the withdrawal of already awarded fixtures and consideration for fixtures in subsequent years.
14. Shooters at WCTSA sanctioned events may not have their finishing scores omitted or hidden from either the results submitted to the WCTSA or from shoot results released on the website or via social media, or when sent to the CPSA for registration purposes.
15. Affiliated grounds / clubs holding sanctioned WCTSA events must allow all fully paid-up members of the Association to compete, unless that shooter is subject to a specific sanction imposed by the Board.
16. Canvassing or inducements will disqualify any ground / club application or tender for sanctioned WCTSA or ICTSC events.
17. Affiliated grounds / clubs must accept the Association's assistance where provided to ensure that the necessary standard of service regarding results and the running of any sanctioned event is consistent with the quality expected of any WCTSA event.



18. Prize money

The awarding of prize money at WCTSA sanctioned events must be in accordance with the current 'CPSA Entry Fees & Prizes' rules, as stipulated in the CPSA General & Technical rulebook.

19. Targets only competitor scores will count towards team selection and classification purposes but will not be eligible for category awards. They may however be considered for an overall high gun award if given by the affiliated grounds.

20. Should an entrant fail to complete a registered shoot, their score and the full levies must still be returned to the WCTSA.

21. Any accident occurring at a WCTSA sanctioned event must be reported to the General Secretary in writing without delay. The Board of a the WCTSA does not accept any liability for any such occurrence at a WCTSA sanctioned event.

4. Shooter's Responsibilities

1. The onus is on every member of the Association to promote safety within our sport.
2. It is mandatory for all competitors and other persons in the vicinity of the shooting area at a WCTSA sanctioned event to wear adequate eye and hearing protection.
3. If a shooter is a member of more than one national governing body but has different classifications for the same discipline they must be entered against their highest classification at a registered event. The shooter must provide this information to the ground.
4. All shooters must ensure their scorecard is returned to the affiliated ground / club at WCTSA sanctioned events. Should a shooter for whatever reason fail to complete the shoot, their scorecard must still be submitted to the affiliated ground / club for inclusion in the shoot results. Failure to do so may result in disciplinary action.
5. Dress Code
 - a. At all WCTSA sanctioned events competitors clothing will be expected to be in a clean and tidy condition and should not contain any messages, images or slogans that may reasonably cause offence to others. Offensive messages or images of a sexual or racial nature are specifically forbidden, as well as any that break the accepted standards of decency and good taste.

Specific examples of personal appearance or garments that will be considered unacceptable are:-



- i. Nakedness of the trunk or limbs other than the lower arms or legs.
 - ii. Wearing of a shooting vest over naked flesh.
 - iii. Sleeveless shirts, t-shirts or tops.
 - iv. Cut-off jeans or trousers or any type of shorts other than 'tailored' shorts.
 - v. Torn slashed or shredded shirts, jeans, trousers, or skirts.
 - vi. Military surplus, balaclava, helmets & camouflage paint.
 - vii. Any excessively worn dirty or dishevelled clothing or footwear.
 - viii. Any footwear that exposes the foot such as flip-flops or sandals.
 - ix. Any other garments or personal appearance that go against the spirit of this code or that seek to exploit any possible loophole within it, at the discretion of the Jury.
 - x. Skirts must be no more than 6 inches above the knee.
- b. At any event which this code is in operation, any participant found to be in breach of any of the provisions detailed above shall be told to rectify their appearance without delay. Failure to comply with such instruction will disqualify the offender from further participation in the event, without the right to a refund, and may additionally render them liable to disciplinary action under the WCTSA disciplinary policy.
6. Perpetual cups and trophies
- a. All must be returned to the WCTSA via the Discipline Reps, or other board members before the next year's event, in sufficient time as to allow presentation at the competition in question. Failure to return the trophy may result in the board obtaining a replacement and billing the shooter who was previously awarded the trophy.
 - b. The holder of a perpetual cup / trophy is responsible for its safekeeping for the period during which they hold the award and will be liable for the loss or any damage to the award. All grounds / clubs or board members presenting perpetual cups or trophies at shoots must complete the WCTSA Tracker Form and return this to the General Secretary within one week of the event.
 - c. All perpetual cups and trophies presented, donated or sponsored to the WCTSA are accepted and competed for as part of the calendar of events, on the basis that they become the property of the Association and its members.



5. Board Policies

1. The management board of the WCTSA undertake to provide a policy for the following matters:-
 - i. GDP
 - ii. Complaints, Disciplinary and Grievance.
 - iii. Bullying and Harassment.
 - iv. Safeguarding and Child Protection.
 - v. Whistleblowing
 - vi. Equality, Diversity and Inclusion Policy
2. These policies shall be kept up to date and reviewed periodically at a frequency to be set by the Board.
3. These policies can be found on the WCTSA website.

6. Discipline Representative Responsibilities

1. The role of a WCTSA. Discipline Representative is to be the conduit between the shooters, affiliated grounds / clubs, and the Board.
2. To represent the Board at any events attended and act for and on behalf of the WCTSA as they may be the only Board representative present.
3. The role is to disseminate any relevant information to both shooters & the affiliated grounds / clubs from Board meetings and ensure any concerns are brought to the Boards attention.
4. They must attend regular 6 weekly Board meetings, along with the yearly AGM, and any other meetings as & when required. Meetings will be held remotely to try and avoid unnecessary travel and expense.
5. They must set the MQS to be used for the next year.
6. They must arrange all fixtures for their designated discipline for Welsh team selections shoots / qualifiers, Welsh Opens & Grand Prix, along with County Finals and help in the organisation of these events on the day if necessary.
7. They must ensure that all WCTSA trophies are returned prior to an event or on the day of competition to ensure the winners can be presented with their trophies.
8. They will be involved, along with the General Secretary and the Chairman, with the organising and hosting of any HCIT events held in Wales.
9. To liaise and work with their elected Team Manager.



7. Welsh Team Selection Procedures

1. The eligibility criteria for anyone wishing to represent any Welsh clay target shooting team at an international event under the authority of the ICTSC, ICTSF, or any other sanctioned event where a Welsh team is competing are as follows:-
 - a. Must be a fully paid-up current member of the WCTSA.
 - b. Must comply with at least one of the following criteria:-
 - i. Born in Wales
 - ii. Parent or grandparent born in Wales
 - iii. Currently reside in Wales and have lived in Wales continuously for 1 year or more prior to the commencement of the qualification process
 - iv. Married to a Welsh National, i.e. married to someone born in Wales
 - c. If a member has already represented another country in any discipline, they must fully comply with the following ICTSC procedure in addition to the above before being eligible to shoot for Wales:-
 - i. A minimum period of two years must have elapsed between last shooting for another country and first shooting for Wales
 - ii. The member must obtain confirmation in writing from the relevant National Association that they agree to release them from their obligation
 - iii. The ICTSC must approve the transfer in advance & no later in the year than at the February council meeting.
2. HCIT Welsh Team Selection Shoots
 - a. Each discipline will hold a series of selection shoots with an agreed number of best scores to count towards team selection. Grounds will be invited to apply to host the selection shoots prior to the Board of Management meeting held at the end of each year. The applications will be reviewed, and Discipline Representatives will discuss how they should be awarded. These will then be proposed by the Discipline Representatives & approved by the Board, along with any other selection criteria deemed necessary.
 - b. The dates of the shoots will be arranged by the relevant Discipline Representatives and submitted to the Board for approval. These dates and venues will then be placed on the WCTSA website and social media platforms. Grounds may advertise their respective shoot(s) on their own platforms but only AFTER they have been announced by the WCTSA.



- c. The selection procedure for each discipline i.e. number of scores to count from the number of selections held can be found in Appendix 2 and will be published on the WCTSA website and social media platforms.
- d. Prior to the commencement of any selection process, Discipline Representatives will propose a minimum qualifying score (MQS) for each category, which is then approved by the Board. A shooter must achieve the relevant MQS at least once at a selection shoot to be considered for team selection.

The current MQS's for each discipline can be found in Appendix 4.

- e. International Status

Shooters attain international status when they have shot for Wales at an ICTSC sanctioned Home International, or when they have represented Wales at another international competition which was sanctioned by the WCTSA board.

Other competitions, such as World and European championships, where Wales is invited to send a representative team may give international status if the WCTSA Board ratifies the event. These other competitions must involve a Board approved selection procedure agreed in advance and would be subject to the same MQS's set above. Shoot entry fees and expenses may be paid to shooters competing in events other than the Home Internationals. This is dependent on Discipline Representatives submitting a proposal to the Board before the event is to be held, and in line with current Board policy on expenses.

- f. If a discipline is holding team selection shoots at more than one ground, then shooter must count scores from a minimum of 2 grounds. This is to prevent shooters qualifying for team selection having only shot at a single ground, which may also be their practice ground. The aim of the selection procedure is to have a team comprised of the best shooters overall rather than the best shooters at a particular ground. Any shooter submitting scores from only one ground when at least 2 grounds have held qualifiers will NOT be considered for selection to represent Wales.

Each discipline may introduce their own specific qualifying criteria in addition to the two-ground rule above, provided this is ratified and minuted at a WCTSA Board meeting.

- g. Scores to count for team selection purposes must be from a completed competition, i.e. shooters must attempt to shoot at all presented targets. Partially completed competitions where shooters have withdrawn or failed to address all the targets will NOT count.



3. HCIT Selection Procedure.

- a. Each discipline will hold a specified number of selections shoots every year. Any member who has not competed in the required minimum number of shoots, met the specified MQS or any other stipulated criteria will not be eligible for the team. The minimum number of shoots required to be eligible for the team is equal to the number of scores to count as outlined in Appendix 2.
 - b. A team selection procedure cannot be changed once the selection process has begun, unless there are extenuating circumstances which have been approved by the Board.
 - c. Team selection is on a points basis and points are calculated from the highest Welsh member's score at the event. The highest Welsh member will attain 0 points, and all other members will attain points equivalent to the difference between their score and the high gun score, i.e. 4 points will be awarded for a score of 92 where the high gun score was 96. For events held over more than one day, points will be calculated from the high gun of each day.
 - d. The members who have the lowest points from the scores to count shall be selected for the team provided they meet all the qualifying criteria.
 - e. Members who qualify for the team in more than one category will be given the choice of which category they wish to represent.
 - f. The Welsh team for each discipline shall consist of Seniors, Ladies, Juniors Veterans and Super Veterans. The number of shooters in each category for disciplines can be found in Appendix 3.
 - g. Any ties for team positions will be decided by determining the highest average score from the shooters 3 best team selection scores.
 - h. Announcement of the Final Team - Official announcement of the Welsh Team for each discipline will be done on the WCTSA website and social media once all scores, MQS's and selection criteria have been checked and verified. This will NOT be completed on the day of the last selection shoot to ensure no errors are made.
 - i. When a shooter is offered a team place, they must confirm their acceptance to the Team Manager / Discipline Representative within seven days of their team place being offered.
4. Course setters in English Sporting and FITASC Sporting who set up a Welsh qualifier course
- a. Ground owners / target setters are allowed to compete at their own shoots.
 - b. However, should a ground owner / target setter achieve the highest score on the day, they are not eligible for any high gun or class monetary prizes.



- c. Should the ground owner / target setter be high gun, they are still eligible to receive 0 points for team selection purposes, but all other shooters points will be calculated from the next highest Welsh shooter's score, not from the ground owner's / target setter's score.

5. Welsh Team Member Standards and Responsibilities

- a. For any member gaining a Welsh team place it is mandatory to acquire, as a minimum, the official Wales team uniforms described below.
 - i. Official Team Wales shooting vest, which must be purchased from the WCTSA General Secretary.
 - ii. Official Team Wales polo shirt, which can be purchased from the WCTSA General Secretary or from Sional.
 - iii. The WCTSA will provide an official Team Wales shooting vest free of charge to all new cap international Junior category shooters.
- b. Shooters attaining international status for the first time will be provided with a WCTSA wire badge which is to be sewn onto a blazer, along with an official WCTSA tie or cravat. These must be worn with the official dress uniform mentioned below.
- c. Welsh team shooting uniform - while shooting shooters MUST wear:-
 - i. Official WCTSA Wales team shooting vest.
 - ii. Official WCTSA Wales team polo shirt.
 - iii. Black trousers or black shorts.
 - iv. No garment can be worn over the shooting uniform when in the act of shooting except in exceptional circumstances e.g. rainwear.
 - v. Failure to adhere to the above regulations will result in disciplinary action, which may include the withdrawal of expenses where applicable, and / or the sanction of exclusion from future Wales teams.
 - vi. Sponsorship of Welsh team clothing or accessories may be permitted provided a request has been submitted to the Board for approval. In every instance this must be ratified in advance by the Board to ensure that both the WCTSA & ICTSC guidelines regarding advertising are met.
- d. Welsh team dress uniform must be worn at opening and closing ceremonies, awards & presentation ceremonies, team photographs & banquets or when requested by the Team Manager.



The Wales team dress uniform which MUST be worn by all team members, is made up as follows:-

- i. Men - Black blazer displaying the official Wales Team blazer badge (wire) supplied by the WCTSA, on the breast pocket. Mid grey flannel trousers, white shirt with collar, Wales Shooting Team tie, grey socks, and black shoes.
 - ii. Ladies - Black blazer displaying the official Wales Team blazer badge (wire) supplied by the WCTSA, on the breast pocket. Mid grey skirt or trousers, white blouse with collar, Wales Shooting Team cravat and black shoes.
- e. Without exception the relevant uniforms as described above must be worn at the appropriate times whilst representing Wales. Failure to wear the correct uniform as instructed may exclude any member from taking part in the event and will subsequently result in disciplinary action being taken by the WCTSA against the member(s) concerned.
- f. All team members attending an event must make themselves available for any opening and closing ceremonies, awards & presentation ceremonies, team photographs & banquets. Failure to do so without any prior agreement with the Team Manager or Board may result in disciplinary action being taken and any expenses withheld.
- Any of these requirements will be communicated to each team member by the designated Team Manager or through instruction from the Board by the General Secretary.
- g. Any expenses to be paid to team shooters when sanctioned by the Board will be done so electronically, and shooters are required to provide relevant bank details to allow secure electronic transfer of funds to their designated account.
- h. All team members of a WCTSA sanctioned event will receive an official written invitation, certificate and any other relevant information from the General Secretary. This will include details of the competition, arrangements for the event and all the rules with regards to dress code.
- i. Welsh Team Fees / Expenses
- i. All shoot entry fees for team members attending a Home International Tournament will be funded by the WCTSA.
 - ii. Each team member will also be allocated a ticket for the post-shoot banquet, and it is a condition that shooters attend unless previous dispensation has been granted by the Board.



- iii. For attending Home International events and other team specific events sanctioned by the Board, shooters may be paid a nominal amount towards their expenses. This will vary dependant on the geographic location and current Board finances.
 - iv. The amount of any expenses is at the discretion of the Board.
 - v. Current expenses being paid can be found in Appendix 5.
 - vi. Shooters will also be reimbursed for any gun permits required to travel.
- j. Welsh Team Accessories

The Board may sanction the production and sale of specific ancillary Welsh team or WCTSA branded accessories e.g. tracksuits, sweatshirts, hoodies etc. Welsh team accessories may only be worn / purchased by members who have attained International team status or who are part of an official team which has been sanctioned by the Board. The Board reserves the right to amend, review and alter items available for sale and their prices, subject to agreement at Board meetings. WCTSA branded items may be purchased by any current member.

8. Welsh Team Manager Responsibilities

1. Team Managers for the coming year will be confirmed by the Board.
2. Team Managers must be fully paid-up members of the Association.
3. Applications for these posts should be made in writing to the WCTSA Board who will make the appointment.
4. The appointment is on an annual rolling basis, with the understanding that the position is one of continual assessment by the Board. If they feel the incumbent is not fulfilling the role to a satisfactory standard, then immediate notice of termination may be given following the home international event that year.
5. Where possible the Team Manager should not be a team member. However, in special circumstances and with prior consent from the Board a team member may be appointed as Team Manager if necessary.
6. Responsibilities - these include but not necessarily limited to:-
 - a. Following the completion of the selection procedure, assist the Statistics Officer in confirming the final team standings.



- b. Contact shooters to confirm their team selection and ascertain their availability for the competition.
- c. Ensure all team members are aware and equipped with the stipulated Welsh team shooting and dress uniforms.
- d. Liaise with all team members prior to an event to assist with any travel arrangements and permit applications where necessary.
- e. Attend any organisational meetings of the events, e.g. Team Manager meeting, opening and closing ceremonies, awards & presentation ceremonies, team photographs & banquets.
- f. Convene and arrange team meetings where required.
- g. Liaise with event hotels to reserve rooms for Welsh team shooters. Deposits can be paid by the WCTSA Treasurer if required.
- h. Ensure shooters are aware of all event information such as opening and closing ceremony times, banquet location, shoot start times etc.
- i. Collate orders and collect monies from all members who require an official team photograph.
- j. Be the conduit between the Board, the WCTSA Treasurer and General Secretary with regards to all other administrative duties, such as additional banquet ticket requirements.
- k. Team Managers who are not part of the team will qualify for expenses the same as team members and receive a banquet ticket. Current expense rates can be found in Appendix 5.
- l. After any Welsh Team event the Manager will submit a shoot report to the Board for social media and the website. This can be brief but should include a summary of the shoot and a resume of the Welsh team's performance and any notable shooter's performance.

9. County Team Competitions

1. The eligibility criteria, qualifying procedure and organisation of county finals is described in a separate policy 'WCTSA County Competition Rules'. At the end of each calendar year the board will review the county competition format and update the county competition rules if required.
